

GAME RULES
« VIRAX ANNIVERSARY DRAW »
From 01/01/2020 to 31/12/2020

Article 1: Organizer

Virax SA, a simplified joint-stock company with a share capital of 3,276,320 euros, with headquarters at 39 quai de la Marne, 51206 Epernay, France, registered in the Reims Trade and Companies Register under Siret number 5620 863 300 064 , known as the “Organizer”, organizes 3 draws in the amount of € 10,000 to be shared between 3 winners in each draw.

A first draw for a registered entry from January 01 to April 30, 2020, a second drawing for a registered entry from May 01 to August 31, 2020, and the third draw for a registered entry from September 01 to December 31, 2020, according to the terms and conditions described in these regulations.

Article 2: Participants
